

‘Women’s Suite iPad Mini Newsletter Sweepstakes 2015’ Rules

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED OR RESTRICTED. ALL PRIZES WILL BE AWARDED. All federal, state, and local laws and regulations apply. This Sweepstakes (this "Sweepstakes") is open to legal residents of the continental United States (the Eligibility Area"), who are age 21 or older at the time of entry. The Sweepstakes begins at 7:00 a.m. Central Time on February 12, 2015, and ends at 11:59:59 p.m. Central Time on Dec. 30, 2015 (the "Sweepstakes Period").

ELIGIBILITY: Only individuals may enter; no entry form from any corporation or other entity shall be accepted. In the case of multiple entries, only the first entry will be accepted. In the event of a dispute over the identity of an online entrant, the entry will be deemed submitted by the registered holder of the e-mail account. WSI is not responsible for technical failures in entry transmission, or lost, late, misdirected, damaged, incomplete, illegible or postage due mail.
